


YLP Session 25



Colleen Cooney, NA Session 258




Brad Liles, NA Session 237


Jan Knudten, NA Session 155

Jan was a U.S. Air Force veteran having proudly served in the Vietnam War as an airplane mechanic with an E-4 ranking. Upon discharge from the Air Force, Jan pursued a career in law enforcement with the Waukesha Police Department beginning on 2/15/1971. He was promoted to Sergeant on 12/14/1980, promoted to Captain on 7/11/1994, and retired as Captain on 12/04/2006. During his nearly 36-year career with Waukesha PD Jan attended the FBI National Academy, graduating in the 155th Session. He remained an active member of the WIFBINAA Chapter for many years. Jan continued his collegiate education and received a bachelor's degree in 1992 from Mount Senario College.
