William E. Hanna, Sr., NA Session 106, (Bill), age 93, passed away on May 22, 2025. Born and raised in Philadelphia, Bill graduated from Overbrook High School and the FBI National Academy. He was a United States Marine Corps veteran serving in Korea. Bill started his career in 1954 as a patrolman for the Borough of Sharon Hill and steadily rose through the ranks. In 1973, he became Police Chief of the Borough of Sharon Hill, retiring in 1993. He then went on to serve a six-year term as District Justice for the Boroughs of Sharon Hill and Colwyn. He was a member of the FBI National Academy Association, National Fraternal Order of Police, Delaware County Fraternal Order of Police, Lodge 27 and Delaware County Police Chiefs Association.


