
Jumbo Shrimp Baseball Game

On May 25, 1966, Orby graduated from the 77th session of the FBI National Academy. He was the fourth police officer from the Honolulu Police Department to attend the FBI NA. Orby was a dedicated member of the Hawaii Chapter, serving as the Secretary/Treasurer in 1984/1985 and the Chapter Historian for many years.

Chester Hughes, NA Session 114, shared the following. "Being one of the founders of the Hawaii Chapter, Orby and his wife, Ruth, knew everyone. Our annual re-training trips to the neighbor islands were something to look forward to because each island went all out in making the events meaningful, and the spouses had a program that they all enjoyed and looked forward to, also. 



Where are they now... This month's feature is on retired Eugene Captain Steve Swenson, NA Session 184. Captain Swenson was born in Brooklyn, New York, but moved to San Diego, California, during his youth. Before his law enforcement career, Captain Swenson was "Baywatch" before Baywatch was cool and served as a lifeguard for the City of San Diego at Ventura Cove and Mission Beach. Captain Swenson was also working his way through the El Cajon Police Department, starting as a Cadet and then a paid intern before being hired as a full-time officer in 1976. He moved to Oregon when he accepted a full-time position with the Oakridge Police Department in 1979. He left for the Lane County Sheriff's Office but was laid off with 43 others soon after. 
